- ◆ **Registration to participate due by April 9** – Submit admittee and one guest's name and \$175 per person to CBA by April 9. The fee includes Sunday night reception at the Ritz, Monday morning full breakfast at the Supreme Court.
- ◆ **Application for admission due to CBA by April 9**-- The application for admission must be submitted to the CBA, HCBA or PBCBA (not the Court) by April 9. Please note, a certificate of good standing from the Florida Supreme Court (not The Florida Bar) is required. - ◆ You may find it preferable to fly into Reagan National Airport as it is only a metro stop away (Pentagon City) from the Ritz Carlton. Taxis and shuttles are also available.
